22.04.2026	<p>At its meeting on 22 April 2026, the Federal Council approved the agreement between the federal government and the cantons on their involvement in the context of the package 'Stabilisation and further development of relations between Switzerland and the EU (Bilaterals III)'. Among other things, it is intended to ensure that the cantons are involved in the application of the institutional elements of the single market agreements – such as the dynamic alignment of legislation or the settlement of disputes. Approval was granted subject to the outcome of the parliamentary deliberations on the package Switzerland-EU.</p> <p>Press release, 22.04.2026</p>
13.03.2026	<p>At its meeting on 13 March 2026, the Federal Council approved the dispatch to Parliament on the stabilisation and further development of Swiss–EU relations package (Bilaterals III). The Federal Council's intention with this bill is to stabilise and future-proof the tried-and-tested bilateral approach with the EU. The package is in Switzerland's interest. It ensures the continuity of economic, scientific and social relations with the EU, Switzerland's most important trading partner. In view of the tense geopolitical situation, stable and reliable relations with neighbouring European countries are of strategic importance.</p> <p>Press release, 13.03.2026</p>
02.03.2026	<p>On 2 March, President Guy Parmelin and European Commission President Ursula von der Leyen signed the agreements comprising the Switzerland–EU package in Brussels. The agreements were initialled by the chief negotiators on 21 May 2025 and approved by the Federal Council on 13 June 2025. The dispatch on the Switzerland–EU package is expected to be approved for submission to Parliament in the course of this month.</p> <p>Press release, 02.03.2026</p>

05.12.2025	<p>At its meeting on 5 December 2025, the Federal Council discussed the results of the consultation on the 'Stabilisation and further development of Swiss-EU relations' package (Bilaterals III). The Federal Council noted that a clear majority of consultation participants were in favour of the Swiss-EU package. Several clarifications and improvements were called for regarding how the agreements would be implemented domestically. After careful consideration of these concerns, the Federal Council decided to make certain adjustments.</p> <p>Press release, 05.12.2025</p>	
10.11.2025	<p>Federal Councillor Guy Parmelin and EU Commissioner Ekaterina Zaharieva signed the Switzerland-EU programmes agreement in Bern on 10 November 2025. This part of the Switzerland-EU package can be provisionally applied with retroactive effect from the beginning of 2025. Switzerland is thus associated to Horizon Europe, the Euratom programme and the Digital Europe programme. The agreement also paves the way for association to ITER, Erasmus+ and EU4Health.</p> <p>Press release, 10.11.2025</p>	
15.10.2025	<p>At its meeting on 15 October 2025, the Federal Council discussed measures to strengthen the involvement of the cantons and Parliament in Switzerland's foreign policy on the Swiss–EU package. Next steps for concluding an arrangement with the cantons and expanding information mechanisms for the parliamentary committees were also set out. These proposals will be included in the Federal Council dispatch expected to be submitted to Parliament in March 2026.</p> <p>Press release, 15.10.2025</p>	
13.06.2025	<p>At its meeting on 13 June 2025, the Federal Council approved the agreements in the new package to stabilise and develop Switzerland's bilateral approach with the EU and opened the domestic consultation process. After Switzerland brought the negotiations with the EU to a successful close in December 2024, the Federal Council finalised the implementing legislation and accompanying measures. Previously unresolved issues concerning wage protection, immigration, electricity and the type of referendum to be held have since been settled and presented to the public over the last five months. The consultation process will last until 31 October 2025. With this package, the Federal Council is aiming for customised sectoral participation in the EU single market as well as cooperation in selected areas. Given the current global unrest, maintaining good relations with neighbouring countries is key.</p> <p>Press release, 13.06.2025</p>	
21.05.2025	<p>The chief negotiators of Switzerland and the EU, Patric Franzen and Richard Szostak, and the Swiss co-negotiators from the relevant federal offices initialled the agreements of the Switzerland–EU package in Bern on 21 May 2025. Parliament will ultimately determine the nature of the referendum in the course of its deliberations.</p> <p>Press release, 30.04.2025</p>	
10.04.2025	<p>At its meeting on 9 April 2025, the Federal Council approved the EU Programmes Agreement (EUPA) along with the associated protocols on education, research, innovation and health. Signature of the EUPA will enable Swiss association in Horizon Europe, the Euratom programme and the Digital Europe Programme to be applied retroactively from 1 January 2025. 21.03.2025	<p>At its meeting on March 21, 2025, the Federal Council approved a package of measures to safeguard wage protection. 08.05.2024	<p>At its meeting on 8 March 2024, the Federal Council approved the negotiating mandate with the EU in its definitive form. 15.12.2023	<p>At its meeting on 15 December, the Federal Council approved the draft negotiating mandate with the EU. The mandate sets out guidelines for the negotiations, which will get under way once the mandate is definitively adopted, after consultation with Parliament and the cantons.</p>

14.12.2023 (nur DE)	The transitional solution with the European Railway Agency (ERA) will be extended until the end of 2024. It enables joint vehicle approvals and safety certificates for cross-border passenger and freight transport.	
05.12.2023 (nur DE)	On December 5, 2023, the 18th meeting of the Joint Committee on the Agreement on Mutual Recognition in relation to Conformity Assessment (MRA) took place in Bern. Switzerland and the EU discussed the implementation of the agreement and developments in EU legislation.	
29.11.2023 (nur DE)	At its meeting on November 29, 2023 , the Federal Council decided to reinforce the Swiss contingent in KFOR with 20 additional members of the armed forces from April 2024. The contingent will be increased to replace the transport unit that Austria is withdrawing from the mission in spring 2024. The additional costs for increasing the maximum number of troops will be covered by the DDPS budget.	
22.11.2023	At its meeting on 22 November , the Federal Council decided to extend for a further year the safeguard clause provided for in the Agreement on the Free Movement of Persons for Croatian nationals coming to work in Switzerland. The number of new work permits for 2024 will remain at the same level as 2023.	
21.11.2023	State Secretary Alexandre Fasel was received by the secretary-general of the European External Action Service (EEAS), Stefano Sannino , in Brussels on 21 November for the biannual consultations on foreign and security policy. In this context, Mr Fasel and Mr Sannino agreed to establish a structured dialogue on security and defence, with the aim of strengthening cooperation in this area. They also discussed the topic of cooperation and solidarity in response to current crises, and exchanged views on various multilateral issues.	
13.11.2023	On Monday, 13 November 2023, State Secretary Alexandre Fasel travelled to London for the annual strategic dialogue between Switzerland and the United Kingdom . He met with Christian Turner, political director, and Peter Wilson, director general for Europe, at the UK Foreign, Commonwealth & Development Office. The discussions centred on the intensive and diverse bilateral relations between Switzerland and the UK, current international affairs, and European matters. The primary objective of the discussions was to enhance political, economic and scientific cooperation between the two nations.	
08.11.2023	At its meeting on 8 November 2023 , the Federal Council reviewed the outcomes of internal discussions and the exploratory talks with the EU. On this basis, it decided to draw up a negotiating mandate. Before the end of the year, it will decide whether or not to adopt it and submit it to the foreign affairs committees (FACs) and the Conference of Cantonal Governments (CCG) for consultation.

18.07.2023	Federal Councillor Ignazio Cassis meets Vice-President of the EU Commission Maroš Šefčovič in Brussels. Talks focus on the progress made in the exploratory talks at the technical and diplomatic level as well as the outstanding issues and next steps to be clarified in the coming months.

This is intended to create the legal basis in terms of data protection for the platform for electronic communication between the bodies responsible for implementing the accompanying measures.

21.12.2021	Director of Land Transport at the European Commission Kristian Schmidt and Director of the Federal Office of Transport (FOT) Peter Füglistaler have signed a decision on Switzerland's continued cooperation with the European Railway Agency (ERA) .	
24.11.2021	Switzerland cooperates with the European Defence Agency in selected areas. The Federal Council has approved an agreement governing the mutual protection of classified information.	
24.11.2021	On 24 November, the Federal Council approved the memorandum of understanding (MoU) with the EU regarding the second Swiss contribution to selected EU member states. Negotiations with partner countries on the relevant implementation agreements can now go ahead.	
17.11.2021	The Federal Council has amended the Drivers Ordinance . With a view to the integration of the new EU law into the Land Transport Agreement, it is thus creating equivalent regulations with the EU on the working, driving and rest times of professional drivers. Most of the amendments will enter into force on 1 January 2022.	
15.11.2021	On 15 November 2021, Federal Councillor Ignazio Cassis travelled to Brussels to meet with Maroš Šefčovič , Vice-President of the European Commission. Mr Šefčovič is Switzerland's new point of contact at the European Commission. The talks focused on relations between Switzerland and the European Union.

01.11.2021	The new social security agreement with the UK will be applicable provisionally from 1 November 2021. It coordinates the social security systems of the two contracting states as the CH-EU Agreement on the Free Movement of Persons is no longer applicable as a result of Brexit.	
20.10.2021	Switzerland is currently a non-associated third country in terms of the EU Framework Programme for Research and Innovation 'Horizon Europe' and related programmes and initiatives. The Federal Council instructed the EAER to provide direct funding to the players concerned and approved the necessary credit reallocations.	
11.08.2021	The Federal Council approved a new social security agreement between Switzerland and the UK. This is intended to ensure the coordination of the social security systems of both states in the longer term following the UK's withdrawal from the EU.	
11.08.2021	The Federal Council adopted the dispatch on the new frontier workers agreement between Switzerland and Italy. The agreement significantly improves the current regulation on the taxation of frontier workers and contributes to maintaining the good bilateral relations between the two countries.	
19.07.2021	The Swiss-EU Joint Air Transport Committee has decided on the adoption of various EU regulations by Switzerland. In view of the COVID 19 pandemic, the requirements for air carriers on the entitlement to slots will be eased. And various provisions on flight and aviation security will be adopted. The new regulations will enter into force on 1 August 2021.	
01.07.2021	Switzerland and the EU recognise the equivalence of passenger rights in public transport. The Swiss/EU Joint Committee on Land Transport has included the corresponding regulations in the Annex to the Agreement on Land Transport.	
30.06.2021	The Federal Council adopted a dispatch on the agreement between Switzerland and the UK on the mobility of service providers (Services Mobility Agreement, SMA). The agreement ensures reciprocal facilitated access for service providers between Switzerland and the UK following the expiry of the Agreement on the Free Movement of Persons (AFMP).	
26.05.2021	The Federal Council undertook an overall evaluation of the outcome of the negotiations on the institutional framework agreement (InstA) . It concluded that there remain substantial differences between Switzerland and the EU on key aspects of the agreement. The conditions are thus not met for the signing of the agreement. The Federal Council today took the decision not to sign the agreement, and communicated this decision to the EU. This brings the negotiations on the draft of the InstA to a close. The Federal Council nevertheless considers it to be in the shared interest of Switzerland and the EU to safeguard their well-established cooperation and to systematically maintain the agreements already in force. It therefore wishes to launch a political dialogue with the EU on continued cooperation.

29.12.2020	The Switzerland-EU bilateral agreements will cease to apply to the UK at the end of the Brexit transition period. These agreements will be succeeded by a series of follow-up agreements that Switzerland negotiated with the UK as part of its Mind the Gap strategy (including Mind the Gap+). Most of the existing rights and obligations between the two countries will continue to apply.	
18.12.2020	The State Secretary of the FDFA, Livia Leu, and Italian Deputy Minister at the Ministry for Foreign Affairs and International Cooperation, Ivan Scalfarotto, signed an agreement to simplify radiometric checks on the export of metal products. This will eliminate the need for radiation protection measurements at the border when exporting metal products.	
14.12.2020	Federal Councillor Guy Parmelin and the Rt Hon Elizabeth Truss MP, the UK's Secretary of State for International Trade, signed the Services Mobility Agreement (SMA). The agreement secures reciprocal, facilitated market access for service providers from Switzerland and the United Kingdom from 1 January 2021.	
04.12.2020	The Federal Council approved an agreement between Switzerland and the UK on the mobility of service suppliers, which will close the imminent gap as of 1 January 2021 when the agreement on the free movement of persons between CH and the UK will cease to apply.	
27.09.2020	In a popular vote, 61.7% of the Swiss people and the majority of the Cantons have voted against the popular initiative 'For moderate immigration (Limitation Initiative)'. Participation: 59.47%.	
01.07.2020		Germany takes on the Presidency of the Council of the EU for a six-month term.
11.06.2020	Parliament approved a credit necessary for the further development of the Schengen acquis. This investment in information systems aims at strengthening security in the Schengen area.	
31.01.2020		The United Kingdom withdraws from the EU; a transitional period runs until 31.12.2020.
01.01.2020	Entry into force of the agreement on the linking of the Swiss and EU emissions trading schemes (ETS), allowing Switzerland and the EU to trade CO2 emission rights.
